Color Rush is a color run where participants will start out clean, and throughout the run, they will be coated with blue, green, pink, purple, and yellow "color." Each section of the run adds a new explosion of color to your clean starting status until you cross the finish line into a final burst of color. The participants will be running or walking a 5K course that is on unpayed trails.

Risks associated with competing in the Dickinson Color Rush 5K Run/Walk, include, but are not limited to, slips, falls, contact with other participants, negligent or wanton acts of other participants, any defects or condition of premises, or color zones, the effects of the weather including high heat, cold temperatures, storms and/or humidity.

The color explosions are food grade cornstarch and are 100% natural and SAFE. As with any substance, you will want to keep it out of your eyes and our color throwers make sure to aim low as you pass by. We recommend that participants wear goggles to protect their eyes and use bandanas or dusk masks to protect mouth and nose.

The "color" does mostly wash out after the event. As with anything dirty, the sooner you wash it the better. We suggest wearing items that you wouldn't mind getting colorful. If you would like to preserve the color in your running shirt, spray it with vinegar and iron it. If you wash your shirt....the color will eventually come out.

Register before Friday, October 14th and the fee is just \$20 with a Color Rush 5K t-shirt (\$15 without a t-shirt)! After October 14th, registration is \$20 without a t shirt.
