On October 19, 2018 Pennsylvania Governor Tom Wolf signed into law the Timothy J. Piazza Antihazing Law, named for the Pennsylvania State University student who lost his life in a fraternity hazing incident in early 2017. The new law amends Pennsylvania's existing Antihazing Law, including requiring additional reporting by colleges and universities.

Colleges and universities are required to make a report of hazing violations and must publish this information on the publicly accessible portion of the school's website. The initial report must be published by January 15, 2019 and going forward institutions will be required to update this report twice a year, on January 1 and August 1 of each year.

The chart below lists incidents of hazing which reported to the college between and adjudicated through the Student Conduct process where the parties involved have been found responsible for Hazing. This date covers the period of January 2015 to December 2020.
