

## **Summary Annual Report**

### **For Emeriti Retiree Health Plan for Dickinson College**

This is a summary of the annual report for the Emeriti Retiree Health Plan for Dickinson College, Employer Identification Number 23-1365954, Plan No. 510 for the period January 1, 2020 through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has insurance contracts with Aetna Life Insurance Co. to pay all medical claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$65,310.

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$4,103,866, as of December 31, 2020 compared to \$3,515,699 as of January 1, 2019. During the plan year, the plan experienced an increase in its net assets of \$588,167. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$959,407, including employer contributions of \$456,450, participant contributions of \$53,234, and earnings from investments of \$449,723. Plan expenses were \$371,240. These expenses included \$59,656 in administrative expenses and \$311,584 in benefits paid to participants and beneficiaries.
