

## **SUMMARY ANNUAL REPORT**

### **For Dickinson College Consolidated Health and Welfare Plan**

This is a summary of the annual report of the Dickinson College Consolidated Health and Welfare Plan, EIN 23-1365954, Plan No. 515, for period July 1, 2022 through June 30, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Dickinson College has committed itself to pay healthcare claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with Ace American Insurance Company, Continental American Insurance Company, Reliance Standard Life Insurance Company, Vision Benefits Of America and Hartford Life And Accident to pay health, vision, life insurance, AD&D, temporary disability, long-term disability, and Dependent/Supplemental Life and Vol AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending June 30, 2023 were \$476,066.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- insurance information, including sales commissions paid by insurance carriers;

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Dickinson College, PO Box 1773, Carlisle, PA 17013) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
