Wendy Moffat taught British literature of the 19th and 20th centuries at Dickinson for 40 years. Her biography, *A Great Unrecorded History: A New Life of E.M. Forster*, was reviewed glowingly on the front page of the *New York Times Book Review* and garnered prizes on both sides of the Atlantic. She is currently completing *Wounded Minds*, a dual biography about the psychic cost of war trauma in America during World War I. Wendy has published on novelists from Jane Austen to Joseph Conrad, narrative theory, biography as a genre, and academic administration in the liberal arts. She first taught “Jane Austen in her Time” in 1989—and a dozen times since, for beginners and advanced English majors alike. Twice Wendy led six-week summer study groups in London. She directed Dickinson’s yearlong program at University of East Anglia in Norwich and established Dickinson’s Mansfield College, Oxford Program in 2012. In 2016 she was named Curley Chair in Global Education. Wendy earned her B.A. and Ph.D. at Yale. She lives in Carlisle and Philadelphia with her husband Donald and their three dogs.

Dear Dickinson Alumni,

Where better to study *Jane Austen in her Time* than in the beautiful parts of England where she lived and set her novels? As Professor of English (now Emerita), I taught Austen for forty years at Dickinson. Now I’m delighted to lead our journey along the arc of her life, from the Hampshire manor house where she lived to the Georgian spa-town of Bath, from coastal Lyme Regis (the setting for *Persuasion*) to her resting place in Winchester Cathedral. Austen was born—like Dickinson College itself—into a vibrant, contentious world in transition to modernity. Austen’s novels embody its fascinations and debates. I will lead four contextual lecture/discussion sessions during the tour. The course is designed to be a workshop in educating ourselves, as best we can from the vantage point of more than two hundred years’ distance, on what we need to know to “read” Jane Austen’s work in the context of her society. By immersion we will learn how architecture, landscape, domestic life, marriage and inheritance laws, pleasures and diversions, and social mores reflect England’s religious, historical, and geopolitical preoccupations at the height of its Empire and the beginning of the Industrial Revolution. This is a tour for people who love literature and history, the arts, and the out-of-doors. It’s a feast for the mind, the eye, and the heart. To whet appetites, over the Spring 2026 term I will conduct a four-session virtual class on Austen’s life and novels. I can promise that my students in Carlisle will envy us.

Here’s a brief taste of the highlights of our eight-day journey. We’ll skirt the hubbub of London with an afternoon and evening in Windsor, site of the oldest and largest occupied castle in the world. Then onto Austen’s Hampshire—the Elizabethan manor house, gardens, and the Austen Museum at Chawton. Here we’ll examine manuscripts, first editions, and material culture. The Georgian leisure spot of Bath—site of the 18c *beau monde* and playground in *Northanger Abbey*, *Sense and Sensibility*, and *Persuasion*—will be our base for six nights. We will explore the Jane Austen Centre, tour the city’s architecture from the ancient Abbey to the *nouveaux-riche* urban planning, explore the Roman Baths, take the waters, and (optional) attend a *musical*. Three day-trips will take us 1) to 18c Stourhead House and Gardens, one model for Darcy’s estate in *Pride and Prejudice* 2) to the Cobb, the breakwater of the coastal resort of Lyme Regis, where naval captains rested during the Napoleonic Wars (and Darwin unearthed fossils that upended scientific debates) and 3) on a walking tour of Oxford (where Austen’s brothers studied), including Mansfield College, the site for Dickinson’s prestigious program and Human Rights Centre. The treasures of the Bodleian Libraries, art and archaeological riches of the Ashmolean Museum, extraordinary collection in the Museum of Natural History, and magnificent Botanic Garden are yours to choose. In Oxford, I will be happy to lead an overview tour for those interested, and there may be some surprises in store. Our final day we repair to Winchester, where Austen died and is buried, and then travel on to our hotel in Windsor.

We will eat and drink in ancient pubs (Oxford’s Bear Inn dates to 1242), glorious tea rooms (frequented by cads like Robert Ferrars and John Thorpe, wannabees like Mr. Musgrove, and meritocratic naval officers like Frederick Wentworth), and authentic South Asian restaurants.

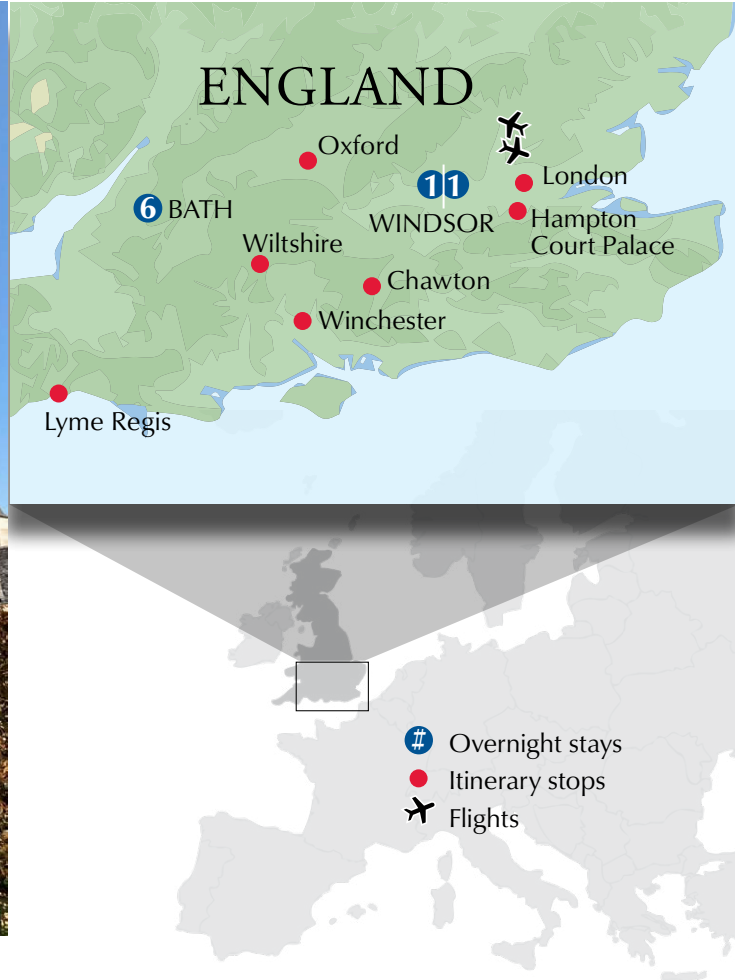

ITINERARY

Tuesday, September 1, 2026: Depart home

Wednesday, September 2: Arrive London, England | Transfer to Windsor | Hampton Court Palace | Welcome reception

Arrive at London's Heathrow Airport (LHR), where you will be met and transferred as a group (time TBD) to Windsor. This afternoon we visit Hampton Court Palace, which was built in the 16th century as a residence for Cardinal Thomas Wolsey, until he fell out of favor with Henry VIII. Then it fell into the hands of the monarchy. After centuries of rebuilding, a stately palace was created with a beautiful mix of Tudor and Baroque styles. The world-renowned gardens are the main attraction, with 750 acres of formal gardens and parkland on the banks of the River Thames. Check-in to our hotel and gather for a welcome reception this evening. *Overnight at the 4-star [Macdonald Windsor Hotel](#). (R)*

Thursday, September 3: Chawton: Chawton House, Jane Austen's House | Bath | Welcome dinner

After breakfast we begin our journey to Bath, stopping along the way in Chawton to visit Chawton House. The house once belonged to Jane Austen's brother, Edward, and it was the "Great House" referred to in many of Jane's letters. The library's collection of books focuses on women's literature in English, holding some of the only known surviving copies of their works. Just down the road, we will explore Jane Austen's House, the most treasured Austen site in the world. Jane Austen's six completed novels were written here, and the first edition copies reside here. Continue on to Bath, where we check-in to our hotel. Gather for a welcome dinner this evening. *Six nights at the 4-star [Abbey Hotel Bath](#). (B,D)*

The Roman Baths, Bath

Friday, September 4: Bath: Walking tour, Roman Baths, Afternoon tea, PM at leisure

This morning, we enter the world of Bath, the only city in the United Kingdom designated a UNESCO World Heritage Site. We walk in the footsteps of Jane Austen's characters as we take a walking tour of the compact city center, a wellness destination since Roman times. Next, we visit the impressive Roman Baths, once the site of one of the great religious spas of the ancient world, dedicated to the goddess Sulis Minerva. The people of Roman Britain bathed here in the hot water of the natural thermal springs, which still flow today. At lunch time, we will enjoy a hearty afternoon tea in the Pump Room Restaurant at the Baths, taking in the traditional ritual of tea, sweets, tea sandwiches, and scones that began in the 1800s. The balance of the day and dinner are at leisure. (B,T)

Saturday, September 5: Bath: No. 1 Royal Crescent, The Jane Austen Centre

We begin our day with a step back in time to the 18th century and enjoy a self-guided visit of No. 1 Royal Crescent, a museum showcasing life in Georgian Bath. After an independent lunch, we visit The Jane Austen Centre, an interactive museum focusing on the life and works of Jane Austen, as well as the Regency period. The balance of the day and dinner are at leisure. (B)

Sunday, September 6: Wiltshire: Stourhead | Bath: PM at leisure, Optional 18th-century musical soirée

After breakfast at our hotel, we drive to Wiltshire and visit Stourhead house and gardens. When Stourhead first opened in the 1740s, it was described as 'a living work of art'. The Palladian house is set amid well-manicured lawns and extensive parkland. The centerpiece of the garden is a lake reflecting classical temples, mystical grottoes, and rare and exotic trees. After a morning of exploring, we return to Bath, where the balance of the day and dinner are at leisure. This evening, you may choose to attend an optional, 18th-century musical soirée (additional cost). (B)

Monday, September 7: Lyme Regis Fossil Beach | Bath

After breakfast we drive to Lyme Regis, a charming seaside town that is part of the Jurassic Coast natural UNESCO World Heritage Site "Dorset and the East Devon Coast." We search for ammonites with an expert at Lyme Regis Fossil Beach, much like Mary Anning, pioneering paleontologist and fossil collector, did in the early 19th century. Lyme Regis is home to the Cobb, the place where Louisa Musgrove fell from the steps in Jane Austen's novel, *Persuasion*. Enjoy an independent lunch and time on your own to explore Lyme Regis before we return to Bath for the balance of the day and dinner at leisure. (B)

Tuesday, September 8: Oxford: Walking tour, time at leisure | Bath

Take a day trip to Oxford, where we explore the town and learn about the connections that Dickinson College has with Oxford. After an orientation walking tour, spend time on your own to perhaps punt on the River Cherwell, visit the Ashmolean Museum, explore the Oxford Botanic Garden, and/or while away some time in a local pub discussing Jane Austen and her books. We return to Bath and gather this evening for dinner. (B,D)

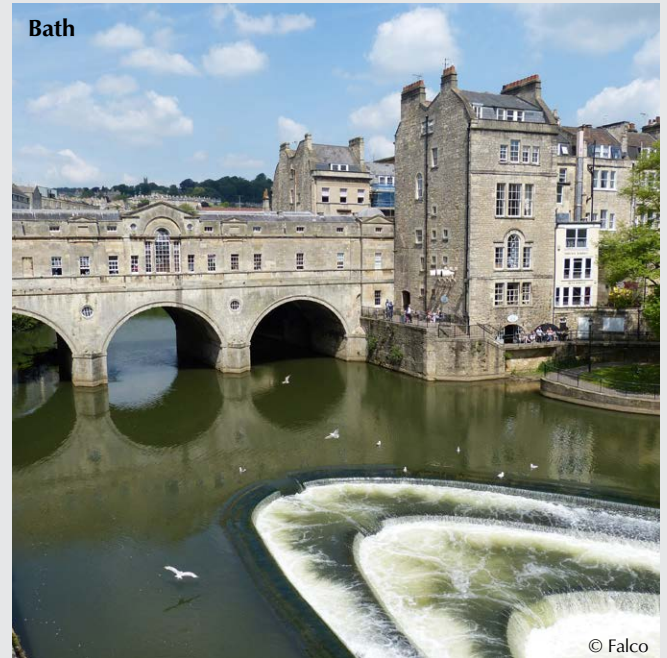
Wednesday, September 9: Winchester Cathedral | Windsor | Farewell dinner

Depart Bath this morning and drive to Windsor, stopping first to visit the historic town of Winchester, the first British capital of England. Explore the grounds of Winchester Cathedral, the town's most prominent landmark and one of the largest cathedrals in the United Kingdom. It is the burial site of kings, including William II, and also of our beloved Jane Austen. After an independent lunch, we continue to Windsor and check-in to our hotel. Gather for a farewell dinner this evening. *Overnight at the 4-star [Macdonald Windsor Hotel](#).* (B,D)

Thursday, September 10: Fly home

Transfer this morning to London's Heathrow Airport (LHR) for flights homeward. (B)

What to Expect



MODERATE: Must be able to walk one to three miles per day on mostly flat, but often uneven, terrain.

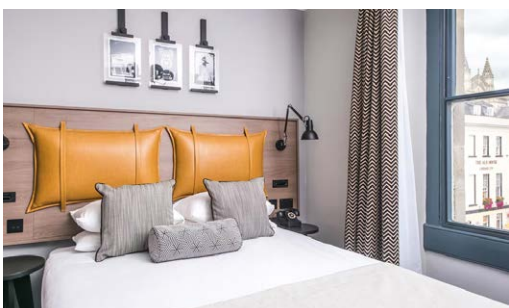
You must be able to make long walks, unassisted, over uneven terrain and up and down steps which may not have handrails. Some sites require strenuous and/or brisk walking or climbing, sometimes with difficult footing. Participants who are not able to walk or stand unassisted for extended periods are kindly advised not to join this tour. All participants are expected to be physically active and not be an impediment to others on excursions, to enjoy traveling as part of a group, and to be ready to experience cultural differences. All participants will be required to follow safety/sanitization protocols set forth by Sponsors/Operator, local staff, and host country laws. Any participant showing signs of illness will be asked to wear a mask when in close proximity to others. If the tour manager decides that a participant cannot visit a site safely or in a timely manner, their judgment will be final. Where possible, an alternate activity may be suggested; additional costs may apply. If you have any questions about your ability to participate, we suggest that you visit your personal physician with this brochure in hand and discuss whether or not this program is appropriate for you. Hotels have been chosen for their excellent locations and generous comfort. Included meals are of high quality. The average temperature in this region at the time of our visit range from the mid-50s F at night to the high 60s F during the day, and there is always a chance for moderate rainfall. Participants should come prepared for pleasant but potentially wet weather. *Complete pre-departure details will be sent to participants.*
