

Summary Annual Report

For Dickinson College Tax Deferred Annuity Plan

This is a summary of the annual report for the Dickinson College Tax Deferred Annuity Plan, Employer Identification Number 23-1365954, Plan No. 002 for the period January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and trust accounts. Plan expenses were \$8,712,367. These expenses included \$79,807 in administrative expenses and \$8,614,905 in benefits paid to participants and beneficiaries. A total of 1,934 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$142,601,361 as of December 31, 2024 compared to \$131,251,058, as of January 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$11,350,303. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$20,062,670, including employee and other contributions of \$4,215,157, and earnings from investments of \$15,077,443.

The plan has a contract with Tiaa-Cref which allocates funds toward group deferred annuities.

Paperwork Reduction Act Statement
