PROJECT DESCRIPTION

The Delta Oral History Project consists of more than 100 life history interviews with African American community leaders in four counties of the Mississippi Delta. These interviews were conducted between 1995 and 1997 by researchers from Dickinson and Tougaloo Colleges, with the research funded by a Collaborative Projects Grant from the National Endowment for the Humanities. Kim Lacy Rogers, Jerry Ward, Jr. and Owen Brooks conducted most of the interviews contained in this collection.

The project also became the basis of Kim Lacy Rogers' book, *Life and Death in the Delta: African American Narratives of Violence, Resilience, and Social Change* (Palgrave/Macmillan 2006). This work reveals the impact of racial and economic oppression, as well as the traditions of community service and leadership in the lives of women and men who became activists. *Life and Death in the Delta* also examines the disillusionment and anger that many Delta leaders feel about the changes that took place during the post-movement years.

The oral histories collected explore, among other things, the civil rights movement in Mississippi communities in the context of a history of white supremacy, racial oppression, and African American cultural vitality. Terrorism, black poverty, and economic exploitation led to a condition of collective trauma and social suffering for thousands of black Deltans in the twentieth century.

COLLECTION DESCRIPTION

The collection is divided into 6 series. Series 1 consists of 118 interview transcripts, typed accounts of Delta interviews conducted by Kim Lacy Rogers, Jerry Ward and Owen Brooks. Interviews are organized alphabetically according to narrator's last name. Series 2 consists of 3 folders of blank and completed consent forms and reply forms. Series 3 consists of 18 folders of research materials, including the NEH grant application, Mississippi census statistics and research notes. Series 4 consists of 7 folders of relevant newspaper, magazine and book articles. Series 5 consists of 11 folders of General Papers, including Correspondence, Budget Information, and Transcript Invoices. Finally, Series 6 includes corresponding media: 9 folders of photographs, reprints and negatives and 201 audio cassette tapes.
